

REGULAR MEETING

APRIL 14, 2015

The Regular Meeting of the Jennings City Council was convened on the 14th day of April, 2015 at 5:30 p.m. in the Jennings City Council Chambers, 110 N. Broadway, Jennings, Louisiana with President Stephen VanHook presiding.

Jennings City Council Members present: Carolyn Simon, District A; Johnny Armentor, District B; Anthony LeBlanc, District D; Stephen VanHook, District E

Jennings City Council Members Absent: Trey Myers, District C

The Prayer was led by Ms. Simon and Pledge of Allegiance was led by Mr. Armentor.

It was moved by Mr. Armentor, seconded by Mr. LeBlanc and carried to **APPROVE** the Minutes of the March 10, 2015 Regular Meeting.

First presented was Ordinance No. 1696 – an ordinance to amend Ordinance No.1685 that established the Pay Plan, Operating and Capital Outlays for the fiscal year July 1, 2014 to June 30, 2015. The budget amendments pertained to the transfer of funds from the General Fund to the Facilities Improvement Fund. After no comment or discussion, it was moved by Mr. Armentor, seconded by Ms. Simon and carried by unanimous voice vote to **INTRODUCE ORDINANCE NO. 1696**.

Next, Mr. Tim Guinn was to address the Council regarding Nuisance Ordinance Violations in relation to his recent complaints. Mr. Guinn stated that he would not need to address the Council, but if Mr. James Cormier was added to the agenda then he would like to be heard at that time.

Next were the Items to Add to the Agenda. First was Barbara & Rocky Roy to speak in regard of the property located at 1330 State Street. Then Mr. James Cormier stated that he would also like to speak in regard to the Nuisance Ordinance Violations. At that time City Attorney Kevin Millican informed the Council that for items to be added to the agenda, it would take a unanimous voice vote.

Councilman Armentor stated that he would not vote in favor of adding any item to the agenda due to the requests coming in so late. Roll Call Vote Required:

At that time Mr. VanHook stated that since it required a unanimous vote, these items could not be added to the agenda.

Mayor Terry Duhon said the two items would be put on the agenda for the May 12 Council meeting. Mr. Tim Guinn stated that he would also like to be carried to the May agenda. Attorney Kevin Millican stated that all three would be put on the May Agenda, but if they wanted to withdraw from the Agenda to call the City Clerk before the next Agenda meeting on May 5.

With no further business, it was moved by Mr. Armentor, seconded by Mr. LeBlanc and carried to ADJOURN this Regular Meeting on April 14, 2015 of the Jennings City Council at 5:40 p.m.
