

REGULAR MEETING

JULY 14, 2015

The Regular Meeting of the Jennings City Council was convened on the 14th day of July, 2015 at 5:30 p.m. in the Jennings City Council Chambers, 110 N. Broadway, Jennings, Louisiana with President Stephen VanHook and a quorum present.

Jennings City Council Members present: Carolyn Simon, District A; Johnny Armentor, District B; Trey Myers, District C; Anthony LeBlanc, District D; Stephen Van Hook, District E

Jennings City Council Members Absent: None

The Prayer was led by Ms. Simon and Pledge of Allegiance was led by Mr. Armentor.

It was moved by Mr. Armentor, seconded by Mr. Myers and carried by voice vote to **APPROVE** the Minutes of the June 23, 2015 Special Meeting.

First was Resolution No. 1703A – a resolution authorizing the Mayor to enter into an intergovernmental agreement with the Jefferson Davis Parish Police Jury for the sale of co-owned adjudicated properties and to execute a contract with *Archon Information Systems, LLC* – d/b/a (*CivicSource*) for adjudicated property sale services. City Attorney Kevin Millican explained that the purpose of this agreement was to enable *CivicSource* to come in and prepare the titles of these adjudicated properties in order to sell them. Adjudicated properties are properties that the City and/or Parish have inherited due to the owner's failure to pay property taxes. The City and Parish have been maintaining these properties at a high cost each year. *CivicSource* would receive an agreed percentage of the profit of the sales. After no other discussion or comment, it was moved by Mr. Armentor, seconded by Mr. LeBlanc and carried by unanimous voice vote to **INTRODUCE & ADOPT RESOLUTION NO. 1703A**.

In other business was to discuss the request of a beer and liquor permit for *CVS Pharmacy #4501 LLC (Louisiana CVS Pharmacy, LLC)* located at 1204 Elton Road. The Mayor stated that all the paperwork was in order and there should be no reason to deny this request. Mr. Matthew Alcock who will be the manager of the store spoke briefly and answered the questions of the Council. After no other discussion or comment, it was moved by Mr. Myers, seconded by Ms. Simon and carried by voice vote to issue a beer/liquor permit to *CVS Pharmacy #4501 LLC* at 1204 Elton Road.

With no further business, it was moved by Mr. Myers, seconded by Mr. Armentor and carried by voice vote to **ADJOURN** this Regular Meeting, on July 14, 2015, of the Jennings City Council at 5:40 p.m.
