

REGULAR MEETING

May 11, 2021

The Regular Meeting of the Jennings City Council was convened on the 11th day of May, 2021 at 5:30 p.m. in the Jennings City Council Chambers, 154 N. Main Street, Jennings, Louisiana with Councilman Johnny Armentor presiding and a quorum present.

Jennings City Council Members present: Carolyn Simon, District A; Johnny Armentor, District B; Clifton LeJeune, District C; Anthony LeBlanc, District D

Jennings City Council Members Absent: Stephen VanHook, District E

The Prayer was led by Mr. LeJeune and Pledge of Allegiance was led by Ms. Simon.

It was moved by Mr. LeJeune, seconded by Ms. Simon and carried by unanimous yeas of voice vote of those in attendance to **APPROVE** the Minutes of the April 13, 2021 Regular Meeting. A question was asked if these minutes were published in the newspaper and the clerk assured that they were. (Published April 18, 2021) It was also stated the minutes will continue to be uploaded to the City's website.

Resolution No. 1769A – a resolution revoking the dedication of surplus equipment belonging to the City of Jennings to make available for sale, donation or for disposal. It was motioned by Ms. Simon and seconded by Mr. LeBlanc to introduce & adopt Resolution No. 1769A. Mayor Henry Guinn stated this was general house cleaning of inoperable equipment done once a year. A question was asked about the wording of the resolution and if there was a list of the equipment. City Attorney Derek Bisig explained the wording to the constituent and provided her with a list of the surplus equipment. After no other public comment, discussion or questions, the resolution was carried by unanimous voice yeas of vote of those in attendance to **INTRODUCE & ADOPT RESOLUTION NO. 1769A**.

It was motioned by Mr. LeJeune and seconded by Mr. LeBlanc to authorize the mayor to accept the lowest responsible bidder for #610 and #57 Grey Limestone for FY 2021-22. (Bids were opened on April 27, 2021 at 10:00 a.m. *Port Aggregates, Inc.* had the low bid for #610 & #57 Grey Limestone to be **picked up** at \$32.80 and \$33.80 per ton respectively. *Rock Solid Materials, LLC* had the low bid for #610 & #57 Grey Limestone to be **delivered** at \$37.50 & \$38.50 per ton respectively.) It was carried by unanimous yeas of voice vote of those in attendance to authorize the mayor to **ACCEPT** the lowest responsible bidder for #610 and #57 Grey Limestone for FY 2021-22.

It was motioned by Ms. Simon and seconded by Mr. LeJeune to authorize the mayor to accept the lowest responsible bidder for Hot Mix (AC-30) Asphalt for FY 2021-22. (Bids were opened on April 27, 2021 at 10:00 a.m. *Prairie Contractors, LLC* had the low bid of \$74.00 per ton) It was carried by unanimous yeas of voice vote of those in attendance to authorize the mayor to **ACCEPT** the lowest responsible bidder for Hot Mix (AC-30) Asphalt for FY 2021-22.

With no further business on the agenda, it was moved by Mr. LeJeune, seconded by Mr. LeBlanc and carried by unanimous yeas of voice vote of those in attendance to ADJOURN this Regular Meeting on May 11, 2021 of the Jennings City Council at 5:39 p.m.
