#### **ORDINANCE NO. 1792**

AN ORDINANCE CREATING THE "CITY OF JENNINGS ECONOMIC DEVELOPMENT DISTRICT NO. 1, STATE OF LOUISIANA;" DEFINING THE BOUNDARIES THEREOF FROM WHICH AREA LOCAL SALES TAX AND HOTEL OCCUPANCY TAX INCREMENTS WILL BE DETERMINED AND USED TO FINANCE ECONOMIC DEVELOPMENT PROJECTS IN ACCORDANCE WITH AND AS AUTHORIZED BY PART II OF CHAPTER 27 OF TITLE 33 OF THE LOUISIANA REVISED STATUTES OF 1950, AS AMENDED; AND PROVIDING FOR OTHER MATTERS IN CONNECTION WITH THE FOREGOING.

WHEREAS, Part II, Chapter 27, Title 33 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 33:9038.31, et seq.) (the "Act") authorizes municipalities, parishes and certain other local governmental subdivisions to create economic development districts to carry out the purposes of the Act, which economic development districts are political subdivisions of the State of Louisiana and possess such power and authority and have such duties as provided by the Act and other law; and

WHEREAS, the City of Jennings, State of Louisiana (the "City"), acting through the Jennings City Council as its governing authority, desires to avail itself of the Act to create an economic development district to be called the "City of Jennings Economic Development District No. 1, State of Louisiana" (the "District"), in accordance with La. R.S. 33:9038.32, from which District local and State sales tax and hotel occupancy increments are expected to be determined and used to fund the City of Jennings Economic Development District No. 1, State of Louisiana Trust Fund; and

**WHEREAS**, La. R.S. 33:9038.39 further permits such economic development districts to levy sales taxes, use taxes, and hotel occupancy taxes at a rate up to two percent (2.00%) for authorized purposes; and

WHEREAS, La. R.S. 33:9038.34(O) provides that this governing authority may create a special trust fund for the furtherance of economic development projects, as defined in the Act, into which the incremental increases in such sales and hotel occupancy taxes shall be deposited and loaned, granted, donated, or pledged in furtherance of economic development projects as defined in the Act; and

WHEREAS, in accordance with the Act, particularly La. R.S. 33:9038.32(B) and La. R.S. 33:9038.39, and Resolution No. 1791M introduced AND adopted on the 10th day of January, 2023, the City has given notice of its intention to create the District, and notice that it will hold a public hearing relative to the proposed creation of the District including a description of the boundaries of the District and containing a map showing the boundaries of the District (EXHIBIT A), which notice has been published once a week for two weeks in the City's official journal; and

**WHEREAS**, on this date, prior to the adoption of this ordinance, this governing authority did hold a public hearing pursuant to the aforesaid notice of intention, at which public hearing on February 14<sup>th</sup>, 2023 at 5:30PM and \_\_\_\_\_\_ objections were received with respect to the creation of the District.

**NOW THEREFORE, BE IT HEREBY ORDAINED** by the City of Jennings City Council, State of Louisiana, acting as the governing authority of the City of Jennings, State of Louisiana, that:

SECTION 1. All of the above "Whereas" clauses are adopted as part of this ordinance.

SECTION 2. <u>Creation of District</u>. Under the authority of La. R.S. 33:9038.32 there is hereby created an economic development district within the City, to be named the "City of Jennings Economic Development District No. 1, State of Louisiana," having the geographical boundaries set forth in Exhibit A attached hereto, which Exhibit A is hereby incorporated in and made a part of this Ordinance, all pursuant to the Act. As provided by the Act, the governing body of the District shall be this City Council. As provided by the Act, the District shall be a political subdivision of the State of Louisiana and shall possess such powers and authority and have such duties as provided in the Act and other law.

SECTION 3. <u>Creation of Trust Fund</u>. Under the authority of La. R.S. 33:9038.34(O), there is hereby created a special trust fund, to be named the "City of Jennings Economic Development District No. 1, State of Louisiana Trust Fund" (the "Trust Fund") the purpose of which will be to fund economic development projects selected by the District in the manner provided by the Act. The Trust Fund shall be established by the Director of Finance or City Clerk of the City of Jennings and maintained as a separate fund, apart from other funds and accounts of the City or other entities, and shall be used strictly for the purposes set forth herein and in the Act.

SECTION 4. <u>Authorization of Officers</u>. The Mayor and City Clerk are hereby authorized, empowered and directed to do any and all things necessary and incidental to carry out the provisions of this ordinance.

SECTION 5. <u>Severability</u>. If any provision of this ordinance shall be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this ordinance, but this ordinance shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this ordinance which validates or makes legal any provision of this ordinance which would not otherwise be valid or legal, shall be deemed to apply to this ordinance.

SECTION 6. Repealer. All ordinances or resolution, or parts thereof, in conflict herewith are hereby repealed.

SECTION 7. <u>Publication; Effective Date</u>. This ordinance shall be published one time in the official journal of the City and shall become effective in the manner provided by La. R.S. 33:406(C).

#### BOUNDARIES AND MAP OF CITY OF JENNINGS ECONOMIC DEVELOPMENT DISTRICT NO. 1, STATE OF LOUISIANA

The following map depicts the boundaries of the District. Following the map is a parcel list of the privately-owned property that makes up substantially all of the District:

BEGINNING at a point located at the intersection of the southern right-of-way line of Interstate Drive and the eastern right-of-way line of LA Highway 26, said point being the POINT OF BEGINNING ("P.O.B."); thence proceed along the southern right-of-way line of Interstate Drive in an easterly direction a distance of 108.41 feet to a point; thence turn left and proceed in a northerly direction along said right of way line for a distance of 60.00 feet to a point; thence turn right and leaving said right of way line proceed in an easterly direction a distance of 190.00 feet to a point; thence turn right and proceed in a southerly direction for a distance of 60.00 feet to a point; thence turn left and proceed in an easterly direction for a distance of 27.74 feet to a point; then turn right and proceed in a southerly direction for a distance of 198.38 feet to a point; thence turn right and proceed in a westerly direction for a distance of 325.00 feet to a point located on the eastern right of way line if LA Highway 26; thence tum right and proceed along said right of way line in a northerly direction for a distance of 200.02 feet to a point said point being the P.O.B., all being subject to a current and accurate survey. Being the same property lying in Section 27, T-9-S, R-3-W, Jefferson Davis Parish, Louisiana, being "1.745" AC." as shown on that plat of survey by Morgan Goudeau & Associates, dated June 22, 2021, a copy of which his attached hereto.
