ORDINANCE NO. 1794

AN ORDINANCE AUTHORIZING THE CITY OF JENNINGS TO ANNEX THE SUNSHINE ADDITION; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED by the City Council to the City of Jennings, Louisiana, duly convened in regular session with a quorum present and voting that:

WHEREAS, a petition has been made by all of the registered voter; all of the resident property owners; as well as representing 100% in value of the property of the resident property owners within the area hereinafter to be described, requesting annexation of the hereinbelow describes property to be included within the corporate limits of the City of Jennings; and,

WHEREAS no registered voters reside within the area to be annexed; and,

WHEREAS, the City Council of the City of Jennings is satisfied that all legal requirements have been met for annexation and that said annexation of the hereinbelow described property would be in the best interest and welfare of all citizens of Jennings, Louisiana; and,

WHEREAS, the economic development and security of the City of Jennings and its citizens would benefit by the property being annexed; and,

BE IT ORDAINED by the City Council for the City of Jennings, Louisiana in regular session duly convened, with a quorum present and voting that the following described property is hereby annexed and incorporated into the City limits of the City of Jennings, Louisiana, to wit:

TRACT 1

Sunshine (No Assigned Parcel No.) Requests Rezoning from S to C-3

A 10.00 acre tract of land being located in Section 21, Township 9 South, Range 3 West, Southwestern District, Jefferson Davis Parish, Louisiana, being more particularly described as follows:

Commencing at the southeast corner of Section 21, Township 9 South, Range 3 West, thence go N 01° 01' 38" E along the east line of said Section 21, T-9-S, R-3-W a distance of 344.54 feet to a point on the north R/W line of Interstate Highway 10, thence N 89° 52' 19" W a distance of 626.59 feet to a Highway R/W marker, thence S 00° 34' 21" W a distance of 5.00 feet to a Highway R/W marker being the Point of Beginning, thence N 89° 52' 19" W along the north R/W of Interstate Highway 10 a distance of 700.00 feet to a 5/8" rod, thence N 00° 34' 21" E a distance of 622.30 feet to a 5/8" rod, thence S 89° 52' 19" E a distance of 700.00 feet to a 5/8" rod, thence S 00° 34' 21" W a distance of 622.31 feet the Point of Beginning as per plat of survey for Sunshine Equipment by Todd J.
