BE IT RESOLVED, by the Mayor and City Council of the City of Jennings, duly convened and acting as governing authority of said City, that;

WHEREAS the City of Jennings strives wherever possible to improve its facilities and infrastructure to better meet the needs of the public it serves; and,

ORDINANCE NO. 1818

AN ORDINANCE TO APPROVE THE AMENDMENT TO THE CHARTER OF THE JEFFERSON DAVIS PARISH ECONOMIC DEVELOPMENT COMMISSION RELATIVE TO ADDING THE TOWN OF LAKE ARTHUR AND THE JEFFERSON DAVIS PARISH POLICE JURY AS MEMBERS, AND REMOVING THE JEFFERSON DAVIS PARISH TOURIST COMMISSION FROM MEMBERSHIP IN THE JEFFERSON DAVIS PARISH ECONOMIC DEVELOPMENT COMMISSION, AND PROVIDING AUTHORITY FOR THE MAYOR TO SIGN SUCH ON BEHALF OF THE CITY OF JENNINGS AND OTHERWISE PROVIDING WITH RESPECT THERETO

WHEREAS, pursuant to the provisions of the Charter of the Jefferson Davis Parish Economic Development Commission adopted by the City Council of the City of Jennings on January 9, 2007, the City of Jennings became a member of the Commission;

WHEREAS, a proposed amendment to the Charter of the Jefferson Davis Parish Economic Development Commission has been submitted to the Council whereby the Town of Lake Arthur and the Jefferson Davis Parish Police Jury would join as additional members of the Commission, and the Jefferson Davis Parish Tourist Commission is removed from membership in the Commission, and providing for number, term and selection of officers, their duties and funding of the Commission;

BE IT THEREFORE ORDAINED by the City Council of the City of Jennings, State of Louisiana, that pursuant to the provisions of LSA-R.S.33:1321 et seq, does hereby approve the Amended Charter of the Jefferson Davis Parish Economic Development Commission, as presented this day to the Council, and authorize the Mayor to execute the Amended Charter thereto on behalf of the City of Jennings, Louisiana;

BE IT FURTHER ORDAINED, that all ordinances and resolutions in conflict herewith are hereby repealed;
