A RESOLUTION DECLARING THE CITY OF JENNINGS HOLIDAY DRIVE WATER LINE EXTENSION PROJECT AS SUBSTANTIALLY COMPLETE; AND REPEALING ALL RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT THEREWITH

WHEREAS, CO-D Construction of LA., L.L.C., as Contractor, has substantially completed the Holiday Dr. Water Line Extension to North of I-10 Project, for the City of Jennings, Louisiana, as of May 8, 2025, in accordance with the plans and specifications contained in the Contract Documents pertaining thereto, with the exceptions noted on the list of deficiencies attached hereto; and

WHEREAS, the City of Jennings, Louisiana desired to accept the work as being substantially complete, subject to the correction within the lien period of the listed deficiencies;
