ORDINANCE NUMBER 1766

AN ORDINANCE WHEREIN THE CITY COUNCIL SETS FORTH THE ADJUSTED MILLAGE RATES AND ROLLS FORWARD TO MILLAGE RATES NOT TO EXCEED THE PRIOR YEAR'S MAXIMUM AUTHORIZED RATES AND REPEALS ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH

BE IT ORDAINED, by the City of Jennings, Louisiana, of the Parish of Jefferson Davis, Louisiana, in a public meeting held on October 13, 2020, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the taxing district voted to increase the millage rates, but not in excess of the prior year's maximum rates, on all taxable property shown on the official assessment roll for the year 2020, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied. Said millage rates are:

	<u>Adjusted Rate</u>	<u>2020 Levy</u>
General Alimony	7.200 mills	7.240 mills
Street Maintenance	8.910 mills	8.960 mills
Library	3.990 mills	4.010 mills

BE IT FURTHER ORDAINED, that the Assessor of the Parish of Jefferson Davis, State of Louisiana, shall extend upon the assessment roll for the year 2020 the taxes herein levied, and the tax collector of said Parish shall collect and remit the same to said taxing authority in accordance with law.

The foregoing Ordinance was read in full, the roll was called on the adoption thereof, and the Ordinance was adopted by no less than two-thirds of the total membership of the taxing authority voting in favor as required by Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B).
