The Special Meeting of the Jennings City Council was convened on the 26th day of June, 2018 at 5:30 p.m. in the Jennings City Council Chambers, 154 N. Main Street, Jennings, Louisiana with President Stephen VanHook and a quorum present.

The Prayer was led by Ms. Simon and Pledge of Allegiance was led by Mr. Armentor.

It was moved by Mr. Armentor, seconded by Mr. LeBlanc and carried by unanimous yeas of voice vote to **APPROVE** the Minutes of the June 12, 2018 Regular Meeting.

Ordinance No. 1736 – an ordinance to adopt the Pay Plan and Operating & Capital Outlay Budget for FYE 06/30/2019. Ordinance No. 1737 – an ordinance to adjust an increase of the water & sewer rates and connections for FY 2018-19 by three percent. The increase is necessary in order to sustain and maintain the increasing costs of the water & sewer systems. It was motioned by Mr. LeJeune and seconded by Mr. Armentor to adopt Ordinance No. 1737. Ms. Simon asked how much was the increase and what was the average increase per customer. Mayor Henry Guinn stated that the increase was three percent and the average increase per customer would be 40 cents.
