The estimated amount of tax revenues to be collected in the next year for General Alimony from the increased millage is \$454,970.60 and the amount of increase in taxes attributable to the millage increase is \$2,513.65. The estimated amount of tax revenues to be collected in the next year for Street Maintenance from the increased millage is \$563,057.54 and the amount of increase in taxes attributable to the millage increase is \$3,142.06. The estimated amount of tax revenues to be collected in the next year for Library from the increased millage is \$251,999.39 and the amount of increase in taxes attributable to the millage increase is \$1,256.82.
