

REGULAR MEETING

NOVEMBER 14, 2017

The Regular Meeting of the Jennings City Council was convened on the 14th day of November, 2017 at 5:30 p.m. in the Jennings City Council Chambers, 154 N. Main Street, Jennings, Louisiana with President Stephen VanHook and a quorum present.

Jennings City Council Members present: Carolyn Simon, District A; Johnny Armentor, District B; Clifton LeJeune, District C; Anthony LeBlanc, District D; Stephen VanHook, District E

Jennings City Council Members Absent: None

The Prayer was led by Ms. Simon and Pledge of Allegiance was led by Mr. Armentor.

It was moved by Ms. Simon, seconded by Mr. Armentor and carried by unanimous yeas of voice vote to **APPROVE** the Minutes of the October 10, 2017 Regular Meeting.

There were no resolutions.

Ordinance No. 1732 – an ordinance to declare the City’s interest in the immovable property located at 324 N. Broadway, Jennings, Louisiana, as surplus property and authorizing the Mayor to sell same at public auction and repealing all ordinances or parts of ordinances in conflict therewith. It was motioned by Mr. Armentor and seconded by Ms. Simon to adopt Ordinance No. 1732. After no public comment or questions, it was carried by unanimous yeas of voice vote to **ADOPT ORDINANCE NO. 1732**. Yeas were from Mr. Armentor, Mr. LeBlanc, Mr. LeJeune, Ms. Simon and Mr. VanHook.

Next was to approve and confirm a beer and liquor permit to *Xiaobing Chen – d/b/a Tokyo Japan* for retail sales – Class A – drinking on premises – located at 1405 Elton Road, Ste. G. Mayor Guinn stated that all the paperwork was in order and there should be no reason to deny this request. Mr. Chen was introduced and stated that he hoped to be open for Thanksgiving. After no other comment or discussion, it was moved by Mr. Armentor, seconded by Mr. LeBlanc and carried to **approve and confirm** the beer/liquor permit to *Tokyo Japan* at 1405 Elton Road, Ste. G. Yeas were from Mr. Armentor, Mr. LeBlanc, Ms. Simon and Mr. VanHook. Mr. LeJeune abstained.

Then was to **announce that the Auction of City Surplus has been postponed** until December 2, 2017 at 10:00 a.m. Location will be at 1625 Thibodaux Road behind the Airport. All items can be previewed online at GuinnAuction.com one week prior to the date of the auction. Items not sold will be disposed and other items of no value will be disposed.

Mr. LeBlanc recognized Ms. Carolyn Barker to give an update on the mural on the Street Department fence on South Main Street.

With no further business, it was moved by Mr. LeJeune, seconded by Ms. Simon and carried by unanimous yeas of voice vote to ADJOURN this Regular Meeting on November 14, 2017 of the Jennings City Council at 5:39 p.m.
