

**REGULAR MEETING**

**SEPTEMBER 12, 2017**

The Regular Meeting of the Jennings City Council was convened on the 12<sup>th</sup> day of September, 2017 at 5:31 p.m. in the Jennings City Council Chambers, 154 N. Main Street, Jennings, Louisiana with Acting President Johnny Armentor and a quorum present.

Jennings City Council Members present: Carolyn Simon, District A; Johnny Armentor, District B; Clifton LeJeune, District C; Anthony LeBlanc, District D

Jennings City Council Members Absent: Stephen VanHook, District E

The Prayer was led by Mr. LeJeune and Pledge of Allegiance was led by Ms. Simon.

It was moved by Mr. LeJeune, seconded by Ms. Simon and carried by unanimous yeas of voice vote to **APPROVE** the Minutes of the August 8, 2017 Regular Meeting.

Resolution No. 1731A – a resolution adopting a compliance questionnaire for fiscal year 2016-2017 audit per request by the Legislative Auditor. This is a routine procedure required each year by our auditor. After no comment or discussion, it was moved by Mr. LeBlanc, seconded by Mr. LeJeune and carried by unanimous yeas of voice vote to **INTRODUCE & ADOPT** Resolution No. 1731A.

Next was to approve and confirm a beer and liquor permit to *Sahibzada Tufail Ahmad – d/b/a Evans Corner Store / Ayeza, LLC* for retail sales – Class B – no drinking on premises – located at 1207 S. Lake Arthur Avenue. Mayor Henry Guinn stated that all the paperwork was in order and there should be no reason to deny this request. After no other comment or discussion, it was moved by Mr. LeBlanc, seconded by Ms. Simon and carried to **approve and confirm** the beer/liquor permit to *Evans Corner Store / Ayeza, LLC* at 1207 S. Lake Arthur Avenue. Yeas were from Mr. LeBlanc, Ms. Simon and Mr. Armentor. Mr. LeJeune abstained.

Then was to approve and confirm a beer permit to *Sahibzada Tufail Ahmad – d/b/a Alexi's Dining / Ayeza, LLC* for retail sales – Class A – drinking on premises – located at 1207 S. Lake Arthur Avenue. Mayor Guinn stated that everything was in order and there should be no reason to deny this request. After no other comment or discussion, it was moved by Ms. Simon, seconded by Mr. LeBlanc and carried to **approve and confirm** the beer permit to *Alexi's Dining / Ayeza, LLC* at 1207 S. Lake Arthur Avenue. Yeas were from Mr. LeBlanc, Ms. Simon and Mr. Armentor. Mr. LeJeune abstained.

Next was to approve and confirm a beer and liquor permit to *Danielle White – d/b/a Club Skky* for retail sales – Class A – drinking on premises – located at 1847 S. Lake Arthur Avenue. Mayor Guinn stated that all the paperwork was in order and there should be no reason to deny this request. After no other comment or discussion, it was moved by Ms. Simon, seconded by Mr. LeBlanc and carried to **approve and confirm** the beer/liquor permit to *Club Skky* at 1847 S. Lake Arthur Avenue. Yeas were from Mr. LeBlanc, Ms. Simon and Mr. Armentor. Mr. LeJeune abstained.

With no further business, it was moved by Ms. Simon, seconded by Mr. LeJeune and carried by unanimous yeas of voice vote to ADJOURN this Regular Meeting on September 12, 2017 of the Jennings City Council at 5:37 p.m.
